In addition, we hereby release and discharge the Ranches from all actions, claims, or demands, that we, our heirs, personal representatives, or assigns now have or may hereafter have for injuries or property damage or loss caused in whole or in part by the negligence of the Ranches. This Agreement does not release the Ranches from liability arising from acts of gross negligence or wanton and willful misconduct.
