Participation Agreement

As lawful consideration for the above mentioned members of our family being permitted to attend the Quickwater Ranch or Sky Mountain Ranch and to participate in their activities, we hereby agree that we, our heirs, personal representatives, and assigns will not make a claim against or sue the Ranch for any injury (including fatal injuries) or damage or loss arising from the negligence or other acts, however caused, of or attributed to the Ranches. In addition, we hereby release and discharge the Ranches from all actions, claims, or demands, that we, our heirs, personal representatives, or assigns now have or may hereafter have for injuries or property damage or loss caused in whole or in part by the negligence of the Ranches. This Agreement does not release the Ranches from liability arising from acts of gross negligence or wanton and willful misconduct.
